SAMPLING HOT TUBS, SWIMMING POOLS & SPAS

There are more and more businesses and individuals that are now providing hot tubs as part of their rental accommodation; this increase in popularity brings with it a heightened risk of hot tub rash & Legionnaires disease.

Hot tub operators & pool technicians need to be aware of the safe operations and legal requirements, as per the new hot tub guidance brought out in January 2017 (HSG 282) and existing swimming pool code of practise (PWTAG).

SAMPLING PRIVATE WATER SUPPLIES

A common misconception is private water supplies must be sampled by the local authorities. This is incorrect; they can only request that owners require a sample which may be completed by a competent third party tested to UKAS accredited specification. Solway Water Management provides this service.



LEGIONELLA RISK ASSESSMENTS

A common misconception is that Legionnaires disease is contracted from drinking contaminated water, this is incorrect. Legionnaires is an airborne disease and infection is caused by inhalation of contaminated water droplets that can enter your lungs where the bacteria will manifest. Due to its airborne capabilities the bacteria can inoculate people remote from premises.

As an employer, landlord, or a person in control of the premises, you are responsible for health and safety and need to ensure that a Legionella risk assessment is carried out by a competent person or company.
